## AGREEMENT .... / 2021

Concluded on ..... between Jakub Pawłowski, ul. Żaglowa 4/11, 02-654 Warszawa, tax identification number, NIP: PL6652367600, hereinafter referred to as "the Organizer", represented by Jakub Pawłowski, and:

### § 1

The subject-matter of this agreement is the lease of exhibition area during the Bridal Fashion fair (hereinafter referred to as the "Fair"), which takes place at the Trade Fair and Congress Centre Global Expo in Warsaw on 12th June, 2021 between 10am and 6pm and between 10am and 5pm on 13th June.

### § 2

The Organizer is responsible for the organization of the Bridal Fashion and authorized to lease the exhibition area.

### § 3

By virtue of this contract the Organizer leases to the Exhibitor the furnished\*/empty\* exhibition area on the premises of the Fair in the amount of approximately ..... m<sup>2</sup> – booth number .....

### § 4

The price of exhibition space is ..... net (say: ..... PLN + 23% VAT).

The price includes extra services ordered separately by the Exhibitor, defined in the Bridal Fashion application form.

### § 5

The exhibitor shall pay a down-payment equal to 50% of the amount mentioned in §4 (increased by 23% of due VAT), i.e. .... (say: ..... PLN) within 14 days of the date of signing the agreement into the bank account:

Lack of payment of the due amount on the date set forth in the agreement results in breach of the agreement and reselling the reserved booth. In case of resignation from participation in the Fair the amount paid shall not be returned. Resignation from the participation in the Fair after 15 May, 2021 does not release the Exhibitor from the obligation to pay the full amount mentioned in § 4.

### § 6

Payment of the remaining 50% (+23% of due VAT) before 15th May, 2021 into the bank account of the Organizer: Jakub Pawłowski, 94 1140 2004 0000 3502 3458 0801 is the condition for participation in the Fair.

### § 7

The exhibitor shall not attempt to bring in and distribute leaflets or any other advertising materials of companies that do not have an agreement with the Organizer, on pain of the contractual penalty of 5000 PLN for each company.

### § 8

The exhibitor shall not give the subject-matter of the agreement in whole or in part to a third party or transfer rights resulting from this agreement to a third party without the consent of the Organizer.

### § 9

The exhibitor shall cover all costs of potential damage done by themselves or parties connected to them in any way. Also, the exhibitor takes responsibility for all commodities, equipment left on the booth.

### § 10

The Organizer ensures security of the booths. The Organizer is not responsible for damage done by the visitors during the fair.

### § 11

The setup and breaking down of booths shall be done only on the date and in place set forth in the agreement with the Organizer, however the full disassembly must be done until 10 pm on Sunday, 13th June, 2021. If any part of the booth is left longer, the Exhibitor shall be charged a fee of 1000 PLN for each commenced hour after the regular lease time.

### § 12

The Exhibitor shall set up their booth only on the area appointed by the Organizer and defined in §3. Any exhibits, decorations etc. shall be placed within boundaries of the booth area. It is prohibited to set up or break up the booth during the Fair on pain of the contractual penalty of 2000PLN.

### § 13

The personnel on the booth must be reported to the Organizer 7 days before the Fair at the latest with the aim to issue exhibitor's ID badges.

### § 14

The Exhibitor is obliged to present products only of legal origin, in the way that does not disturb other exhibitors or breach the law, and their potential sale must be recorded with the aim of due tax to be paid.

### § 15

The Organizer reserves the right to film or photograph exhibits on the premises of the fair and to use these materials for marketing purposes.

### § 16

Any amendments, alterations or variations of this agreement shall be made in writing in an addendum, otherwise being null and void. Any declaration of intent signed by persons authorized to represent that is faxed shall be treated as meeting the requirements of a written form.

### § 17

In case of matters not regulated by this agreement the appropriate regulations of the Civil Code and other laws shall apply.

### § 18

The Exhibitor declares that he is a VAT payer and authorizes the Organizer to issue a VAT invoice for the participation in the BRIDAL FASHION fair and other services associated with the Fair without the signature of the recipient of the invoice within the meaning of the relevant regulations of the goods and services tax act and the excise duty act (VAT).

### § 19

This agreement has been prepared in two identical counterparts one for each of the parties.
